

OFFICIAL RULES FOR RADIO CAMPESINA CESAR E. CHAVEZ COMPUTER GIVE-A-WAY

The Radio Campesina Cesar E. Chavez Computer Give-A-Way will run from March 1, 2008 through March 31, 2008.

ELIGIBLE TO ENTER:

Students, teachers, and interested listeners are invited to submit letters to the National Farm Workers Service Center, Inc., the Farmworkers Educational Radio Network, Inc., and Radio Campesina Bakersfield, Inc. (collectively "Radio Campesina") describing the Cesar E. Chavez, the historical events of the Farmworkers' Movement, their life and contribution of farmworkers, and or how a day of service will honor the life of Cesar E. Chavez.

Letters can be sent vial fax, email, personal delivery, U.S. Postal service to any Radio Campesina station.

Letters will be selected at random by Radio Campesina Station Management and Staff and throughout the month of March 2008, fifteen (15) listeners will receive a computer, to be given away based upon the nature of the letter submitted by the listener. Radio Campesina Management and Staff will decide, in its sole and absolute discretion, who will receive a computer.

ADDITIONAL RULES:

Lister must be present in person to receive a computer.

Must bring proper photo ID to claim computer.

Winner will be responsible for the payment of all taxes.

Winner may NOT have another person pick up, be present in their stead during the actual give a way,

The promotion is for entertainment purposes only. No purchase necessary.

Listeners are ineligible to participate in the promotion if they have won over \$500 in cash or merchandise at any time during the past twelve (12) months prior to the March 1, 2008.

Participants may not be employees of Radio Campesina or any of its corporate or station affiliates.

Entry materials that are incomplete or illegible are void and disqualified.

All participants who participate in the Promotional Give-A-Way herein expressly consent to and grant Radio Campesina a right to use the listeners name, likeness, photograph, hometown and biographical information without further permission or compensation, except where prohibited by law, in any future publicity carried or in connection with any contest or promotion by Radio Campesina.

By accepting a prize, winner agrees to hold Radio Campesina and its affiliate, officers, directors, agents, employees and assigns, harmless against any and all claims and liabilities, including without limitation, property damage, personal injury and/or death arising out of winner's participation, use or misuse of the prize. Prize winners assumes all liability for any injury or damage caused or or claimed to be caused, by participation in this give-a-away and promotion. Radio Campesina has the right to suspend or terminate the promotion in the event the administration, security, fairness, integrity or proper conduct of the promotion is jeopardized.

The Station Manager shall have the sole and exclusive authority to resolve all challenges, protests, disputes and appeals and such Manager's decision shall be binding and non-appealable. Radio Campesina reserves the right to substitute a prize for one of equal or greater value in the event that the advertised prize is not available. If a listener is dissatisfied from the promotion for any reason, the listener's sole and exclusive remedy is to discontinue participating in the promotion and give-a-way.
